
Public Survey Results – Master Plan Input – Summer 2022

Introduction – A survey on a range of topics regarding land use and planning in Lake Township was announced on the Township's website and in the Township's newsletter, which was sent to all property owners. People attending the Planning Commission's June 16, meeting, which included a public input session on the Master Plan, were encouraged to complete the survey. The survey was available online, which was the overwhelming method most respondents used, but it was also available in a paper version. A total of 129 responses were received. This summarizes all responses.






What is the biggest threat to the viability of our township as a desirable place to live? 128 responses











One respondent opposed the proposed Crystal Lake Watershed Overlay Ordinance amendments as bad policy, but a different respondent was strongly in favor of the type of requirements in the proposed amendments.

One off responses included: opposition to events like the ironman, support for renewable energy, support efforts to remove invasive species, impose noise restrictions.





Would you like to see more land utilized for agriculture in the Township? 128 responses






Question #19 -

The Township's ordinance and policy with respect to short term rentals should . . . 129 responses




What is your opinion about having the scenic drive for motor vehicles in our Township? 128 responses
