#### New Business:

- 1. Election results from the August 2, 2011 Special Election. Thank you to all the election inspectors who gave their time for this election. The results were 92 votes cast with 54 yes and 38 no.
- 2. MTA information. Township has been contacted about switching our worker's compensation coverage to a different carrier. More information will be needed before a decision is reached.

### Old Business:

1. Bill spoke with Ann Bourne and the work on the boat launch at the end of Lake Michigan road is scheduled to begin about mid-September and last about 2 weeks. Bill was also contacted about the beach at Point Betsie Lighthouse was asked if the Township would like to consider taking over the area and making it into another park. There are several major issues there: trash, toilet facilities, late night parties, bon fires.

County updates: Roland Halliday, County Commissioner-Update on County Issues. Agrees with the problems being faced at the Point Betsie Lighthouse beach area. 3 finalists for County Administrator will be interviewed. This will be open to the public. The removal of phragmities is going ahead with a request to the public to identify areas that need to be treated. All departments in the County are being asked to trim from their budgets. MSU Extension office may ask for a millage to continue operations. Question was asked who was in charge of the County Equalization Dept... The duties are currently being divided among the staff and Tom Longanbach (former Director) is coming in on weekends to help out. Hopefully a new Director will be in place soon with a start date of October 1, 2011. Next County Household Hazardous Waste drop off will be on Saturday August 13 at the Road Commission in Honor.

*Township Depts.:* Final Township clean up day will be Saturday August 27 from 8am until noon. We are still looking for volunteers.
