They feel that since Beech St. is designated as a public road that the Road Commission should have some responsibility to maintain it. She will be going to the next Road Commission meeting and will get back to us on their decision.

Commissioner Jeannot asked the Board if they would have any objection in placing a survey on Broad Band coverage in with the winter tax bill. Supervisor Grobe said there shouldn't be a problem but she would like to see a copy of the survey.
